This Sustainability policy covers all SUMS group activities and supports the wider environmental, social and economic activities of all the operating divisions of the group.

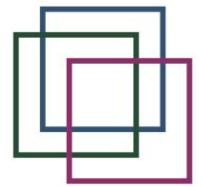

- Develop an understanding of our own unconscious biases, and develop guidelines to reduce barriers to tendering for underrepresented groups, and to embed social value into our procurement processes
- Recognise our financial impact upon the HE sector and fully embed responsible procurement in our procurement processes, to ensure the economic sustainability of the SUMS group and our supply chain.
